

ORDINANCE NO. 18-774

AN ORDINANCE ACCEPTING A TRACT SPLIT FOR LANDS OWNED BY STEVE EDWARD YOUNG, SUCCESSOR TRUSTEE OF THE YOUNG LIVING TRUST, U/D/T OCTOBER 20, 2009, LOCATED WITHIN THE CITY OF GENTRY, ARKANSAS; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES.

WHEREAS, a proposed Tract Split for certain lands owned by Steve Edward Young Successor Trustee of The Young Living Trust, u/d/t October 20, 2009, more particularly described on the Tract Split Surveys attached hereto and incorporated herein by reference, and situated in part of the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 9 and part of the W $\frac{1}{2}$ of Section 9, all in Township 18 North, Range 33 West, Gentry, Benton County, Arkansas, has been submitted to the Gentry Planning Commission for consideration, and the Planning Commission has recommended approval of the Tract Splits, in accordance with the provisions of the City of Gentry's Municipal Code; and

WHEREAS, said Tract Split into Tracts 1-2 as to the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 9; and into Tracts 1-5 as to the W $\frac{1}{2}$ of said Section 9, as shown by their respective legal descriptions is attached hereto as Exhibits "A" and "B", and incorporated herein by reference as if set forth word for word; and

NOW THEREFORE, be it ordained by the City Council for the City of Gentry, Arkansas:

Section 1: That the Tract Split for Steve Edward Young Successor Trustee of The Young Living Trust, u/d/t October 20, 2009 into Tracts 1-2 as to the W $\frac{1}{2}$ of the NE $\frac{1}{4}$ of Section 9; and into Tracts 1-5 as to the W $\frac{1}{2}$ of said Section 9, as shown by the legal descriptions on Exhibits "A" and "B" attached hereto and incorporated herein by reference as if set forth word for word are hereby approved and the same should be and is hereby accepted and approved for all purposes.

Section 2: That the Mayor and Director of Finance be and are hereby authorized and

directed to evidence the acceptance of said Tract Split by certifying said acceptance on the Tract Split.

Section 3: Emergency. Certain factors exist to make finalization of this Tract Split urgent, including sale or transfer of the property or some portion thereof. Accordingly, the immediate effectiveness of the provisions of this Ordinance is necessary and proper for the preservation of the peace, health, safety, and welfare of the residents of Gentry, Arkansas; and, therefore, an emergency is declared to exist, and this Ordinance shall be in full force and effect from and after its passage and approval.
